I. Introduction

The European Union is committed to user privacy.

II. Why do we collect, store and process your data?

The processing operations on personal data linked to the organisation and management of this consultation are necessary for the management and functioning of the Commission, as mandated by the Treaties, and more specifically in Article 5 of TEU, Article 13 TEU and Articles 244-250 TFEU, and in accordance with Article 1 and Article 110f TEU.

III. Who is responsible for the processing of your data? (Controller)

The controller responsible for processing these data is the Head of the Unit "EU Bookshop and CORDIS" at the Publications Office of the European Union.

IV. What personal data do we collect?

Identification Data

No specific personal data is required to participate in this survey and all questions are optional. Unless you provide any further details, no information is collected that can identify you personally.

At the end of the consultation you have the option of leaving your email address so that you can be contacted for further research on CORDIS services. This is voluntary and your email address will not be shared with any third parties.

Technical information

The survey application is hosted in Spain by an external contractor of the Publications Office.

The system uses cookies to identify your visit to help track web traffic. If you received an invitation by email to reply to this survey, we will track if the email was successfully delivered and opened. According to the URL used, the type of source of your visit to the survey is also identified (from email, website or social media). None of these techniques are intended to identify you individually or to collect personal or confidential information.

V. To who are your data disclosed?

The access to all personal data as well as all information collected in the context of this consultation is only granted through user id and password to a defined population of users, without prejudice to a possible transmission to the bodies in charge of a monitoring or inspection task in accordance with Community legislation. These users typically are members of the Unit organising the consultation inside the Publications Office, and its contractors.

No personal data is transmitted to parties which are outside the recipients and the legal framework mentioned.

The European Commission will not share personal data with third parties for direct marketing purposes.

VI. How long are your data kept?

Your personal data will remain in the database until the results have been completely analysed and will be rendered anonymous when they have been usefully exploited, and at the latest after 1 year from the end of the consultation.

If you provided your email address at the end of the consultation, your personal data will be part of a list of contact details shared internally amongst the staff of Commission for the purpose of contacting you in the future in the context of the Commission activities.
